

CHP RV/Camper Useful Info

Welcome to CHP!

We hope you enjoy being a guest of the Park, your show and camping experience. To ensure everyone's safety and enjoyment as well as making sure the Park is maintained to the highest standards, we are attaching our RV Rules and Regulations. If you have any questions, please direct them to the show secretary or a member of the CHP staff.

1. All RV's must park in their spot assigned by the show secretary. DO NOT randomly pick a spot and leave your RV. It will be towed at your expense.
2. There will be a \$100 fine for any RV's not removed in a timely manner and any site not left how it was found (clean-up including no trash left behind, nothing dumped, no CHP equipment removed).
3. RVs may arrive at the beginning of the show (in general this is one day prior to the start of the show) and must leave when the competition ends. If you need to plan to stay longer this must be done in advance.
4. If a competitor is renting an RV from a third party, CHP must have contact info for the rental company/person in addition to the competitor.
5. RVs are responsible for all their own hoses, cords, etc.... needed for hook-up. All spots are equipped with water and 30-amp, 50-amp or both electrical outlets.
6. There is NO DUMPING OF ANY WASTEWATER at CHP.
7. Please see the attached "Useful Information" Sheet for more info regarding pump-out facilities.
8. NO OPEN FIRES are permitted! No fire pits, no campfires. Grilling is allowed in the camper/RV areas but must be always monitored. No grilling is allowed in the barn areas.
9. Inflatable pools are not permitted due to the amount of water necessary to fill them.
10. Please do not remove trash cans from other areas of the park and take them to the RV sites.
11. **CHP DOES NOT have 24-hour RV assistance. There is no RV assistance after office hours except in the event of an emergency. Please do not contact the show secretary, CHP maintenance, etc.... after 6pm unless you have a true emergency. Late arrivals do not constitute an emergency.**

Helpful Info

- All RV hook-ups are equipped with either 30amp and 50amp electrical service or just 50amp. Please come prepared with any necessary adaptors you might need.
- All RV hook-ups are equipped with water spigots. Please bring your own hoses. You may need splitters at some hook-ups.
- IMPORTANT - if you are running a lot of electrical and you usually use 30amp service please consider using a 30 to 50 amp adaptor and plug into the larger outlet to avoid tripping the breaker. We do have a limited number of these adaptors available for loan in the office with a deposit.
- CHP does not have a pump out service, sewage hook-up or dump station.
- Pine Lake RV Resort is located at 32482 Creek Rd., Wagram, NC 28396 and has a dump station. They are open during business hours for this service and their number is 910-706-2019. This is approximately 11 miles from CHP. They charge \$50 which is the equivalent of a one night stay, and they do offer military discounts. **They take cash only.**
- Pump out service is available through our porta-potty provider. Their information is: Little John, 910-944-5555. CHP does not make these arrangements- you must call them directly.
- **No open fires are permitted!** No fire pits, no campfires. Grilling is allowed in the camper/RV areas but must be always monitored. No grilling is allowed in the barn areas.
- Pools are not allowed. Please do not fill baby pools, dog pools, etc....
- If you contain dogs in a fenced area at your camper spot and they dig, please make repairs before you leave.
- DO NOT leave garbage (bags, bins, loose garbage, etc...) at your campsite. You are welcome to use the CHP dumpsters. Garbage left at campsites will result in a bill for pick-up.
