I recognize that there is a significant element of risk involved in horseback riding and the handling of horses. I hereby affirm that I am fully capable of participating in such activities and I certify that I have no physical condition which might interfere with my capability to participate in horseback riding. Knowing the inherent risk, damage, and rigor involved in horseback riding, and willfully informed, I assume all responsibility for myself and/or my child for bodily injury, death, loss of personal property and all expenses thereof, which may occur as a result of my/my child's participation in the handling of horse(s) and /or horseback riding and waive any and all claims which may result therefrom. I also agree should there be any damage to the property to Setters Run Farm, LLC it will be the rider's sole responsibility for replacement or repair.

I recognize that the risk of serious injury is increased by not wearing a certified helmet while horseback riding. I agree to wear a certified protective helmet at all times and understand that all riders are required to wear certified helmets any time mounted on a horse.

I have read, understand, and agree to the terms and conditions stated herein. I acknowledge that this agreement shall be effective and binding upon me/my child during the entire period of my/our participation in handling of horse(s) or horseback riding upon the premises of Setters Run Farm, LLC. By signing below, I attest that any outside instructor invited to teach on my behalf has liability insurance with a limit of at least two million dollars. I further understand that this liability coverage is required as a condition of my presence on Setters Run Farm, LLC and use of its facilities and cross-country course.

Chapter 99E of the North Carolina Statutes 99E-2 Liability: Except as provided in subsection (b) of this section, an equine activity sponsor, an equine professional, or any other person engaged in equine activity, including a corporation or partnership, shall not be liable for an injury to or the death of a participant resulting from inherent risks of equine activities and, except as provided in subsection (b) of this section, no participant or participant's representative shall maintain action against or recover an equine activity sponsor, an equine professional, or any other person engaged in an equine activity for injury, loss, damage, or death of the participant resulting exclusively from any of the inherent risks of equine activities.
